Welcome to the Arf and Running Agility Club's second NADAC trial. Thank you for attending!! We hope to have a wonderful, fun trial. Please read the rules & information listed below.

### **Trial Policies and Information**

#### **FEES/ENTRY:**

- Pre-entries only will be accepted and there will be no entries accepted after July 20<sup>th</sup>.
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, an act of God, public emergency, an act of public enemy, or any other cause beyond the control of the organizing committee.
- There will be no refunds for entries in the event a dog and/or handler are dismissed from competition regardless of the reason for such dismissal.
- A withdrawal from the competition after the closing date due to an injury and/or illness and/or a bitch coming into season after the closing date will be eligible for a refund up to 75% of the total entry fee paid.

**IMPORTANT.** Please check your dog's NADAC registration number on your trial confirmation as soon as you receive it; also, please check the copy of the results posted at the trial. You should report any errors to the Trial Secretary immediately.

NADAC no longer hand checks for discrepancies in the records we send them at the end of the trial. Instead, they post the trial results to the files section of the [NADACAgility@yahogroups.com](mailto:NADACAgility@yahogroups.com) list within two weeks after receiving them from us. The trial results will remain on the list for at least thirty (30) days. Please accept the responsibility to review those results, and check that your registration number and qualifying points, as reported by the club, are correct. You can join the NADAC Agility list and set your settings to "no mail". You'll be able to view trial results and find discrepancies (if any) without receiving list mail. Contact NADAC **only** if your registration number or qualifying results are shown incorrectly on the list. Otherwise, you do not need to do anything.

**Levels.** Points earned at a higher level of a class, prior to the completion of the lower level title, will no longer be banked by NADAC for future use. As of June 1, 2006 if a dog earns points in a level of a class that they are not eligible to title in, those points will not be added to the dog's records.

#### **TRIAL:**

- All dogs for a given class should be present at ring side at least one-half hour prior to the start of the scheduled classes for walk through and briefing. Any dog and handler not present when they are called will be ineligible to run.
- Running order is determined alphabetically. Handlers with more than one dog in a class will be separated where possible.
- There will be no same day move-ups: however, if you title on Saturday, you may move up the next level on Sunday. Move-up forms will be available at our hospitality table (or see show secretary). Completed forms must be in the designated place at the end of the day Saturday.
- Flat Ribbons will be awarded to first through fourth places in all jump heights in all classes except for Chances. Chance class is pass/fail only so there are no placement ribbons. Qualifying Flat Ribbons will be awarded for those achieving a qualifying score. Rosette will be awarded for those finishing a title and NATCH ribbons/rosette and a jump bar will be presented to those completing a NATCH at this trial.
- **NO AGGRESSIVE DOGS OR PEOPLE ARE ALLOWED.** This trial is to have fun with your dogs and enjoy the sport of agility.

**SITE:**

- All dogs must be on leash when not competing in the ring. Under no circumstance should a dog be tied to anything and left unattended. Remember to clean up after your dog so that we can use these grounds in the future.
- This trial is outdoors on grass and there is plenty of crating space available. There are lots of large trees but a shade tent and adequate rain protection is highly recommended. There will be a pool and water hose available for dogs.
- **WARNING:** Do not park long term on the access roads at the VA grounds. Please park in only designated parking spots in the parking lot next to the administration building (across the street from the ring). The VA police department will (and has) ticketed vehicles parked on the access roads in violation of posted signs.

**FOOD:** There will be food concessions on site during the trial.

## AGREEMENT

### **Must be signed and accompany all entries**

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

- 1.1. As used here 'NADAC' means North American Dog Agility Council, Inc., its members, officers, directors, employees, show chairs, show committees and agents.
- 1.2. Exhibitor/owner, agree to abide by the rules and regulations of NADAC, and any other rules and regulations appearing in the premium for this event.
- 1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
- 1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the floors, stairways, halls, lighting, security measures or lack of, electrical appliances, fitting, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.
- 1.5. Exhibitor/owner release NADAC (including NADAC officers, directors, employees, and members), Arf and Running Agility Club (including its officers, directors, and members, and event organizing committee), the Fort Harrison VA Hospital (including its officers, agents, and employees) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assume sole responsibility for and agree to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury, or death may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.
- 1.6. Exhibitor understands there is a returned check fee of \$15.

### NOTICE TO EXHIBITORS

**Exhibitors through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations and agree to abide by all rules in effect at the time of the trial. Dogs must be registered and have a valid registration number before entries will be accepted. Pending numbers are no longer accepted.** You can register your dog online at [www.nadac.com](http://www.nadac.com) and receive a registration number immediately. The Current Jump Height Table, Breed Exemption List, description of classes, levels, and divisions are included in the current Exhibitors Handbook. Thru submission of entry, exhibitors acknowledge they are familiar with the rules in the current Exhibitors Handbook. ## DIRECTIONS TO TRIAL

### Fort Harrison VA Hospital, 1892 Williams St. (off of Hwy 12W), Helena, MT

#### From Helena (or west):

Go west on Euclid Ave (Highway 12 west) until Williams Street. The Corner Bar should be on your right at the corner. Turn right onto Williams and go about 1.2 miles. You will see the entrance to the VA hospital in front of you at the first stop sign. Continue straight ahead towards the main administration building and park in the parking lot next to the admin building. The ring is in the middle of the grounds across the street from the parking lot. **\*\*\*NOTE: The VA police will ticket cars in violation of posted signs, please park in the parking lot after unloading.**

#### From (Missoula, Deerlodge, or the east):

As you approach Helena from the west traveling on Highway 12, you will see the Broadwater athletic club on your left and signs for the VA hospital and Ft. Harrison. This means you are getting close to the turn for Williams Street. Watch for the Corner Bar and the Edge Bar on your left. The road on the left before the Corner bar is Williams Street. Turn left onto Williams Street and go about 1.2 miles. You will see the entrance to the VA hospital in front of you at the first stop sign. Continue on straight towards the main administration building and park in the parking lot. The ring is in the middle of the grounds across the street from the parking lot. **\*\*\*NOTE: The VA police will ticket cars in violation of posted signs, please park in the parking lot after unloading.**
